

# CAMPSITE REGULATIONS

1. The site is open for camping during various major events at the Hockenheim Ring for a user fee. Bookable via the ticket shop at [www.hockenheimring.de](http://www.hockenheimring.de). These are temporary camping areas. The operating/use periods for the respective event must be observed. Wild camping is prohibited and will be prosecuted by the authorities.
2. Access to the campsite is only permitted after payment of the user fee and successful access control. On arrival, the security staff will allocate the area booked in the online shop for the tent of the individual camper including his vehicle, caravan with towing vehicle or motorhome. The booked area may not be exceeded.
3. During the stay on the camping area, the issued wristband has to be worn clearly visible by all persons. The wristband serves as an access authorisation for all temporary campsites (except VIP camping offers).
4. Access and departure by motor vehicles may be restricted by the police during events for reasons of traffic safety.
5. Walking speed must be observed when driving a vehicle on all campsites.
6. Commercial operations on all camping areas is prohibited, i.e. travelling performers and their superstructures, persons conducting business, offering or selling goods. This requires written permission from Hockenheim-Ring GmbH. A normal booked overnight stay is allowed at any time. Likewise, the entry of transport vehicles for commercial use is prohibited.
7. The following items and activities are prohibited in the camping areas:
  - Grills (charcoal/gas/electric) may only be operated with a stand/base (minimum distance from the ground: 30 cm). Grilling is completely prohibited from forest fire danger level 3 onwards!
  - Lighting and maintaining open fires, smoking in the forest and lighting & setting off fireworks
  - Noise that disturbs the peace (e.g. loud music systems),
  - Moving tents with trenches
  - Operating a vehicle except for arrival and departure at the campsite
  - Driving nails into trees or otherwise damaging the site
  - Bringing animals of any kind
8. A limited number of electricity connections (distribution boxes) are available for common use at the campsites of Hockenheim-Ring GmbH. You need to bring the appropriate adapters (16A CEE blue - Euroschuko) for connection yourself. Only extension cables or cable drums suitable for outdoor use are permitted for further sub-distribution. The maximum load may not be exceeded and only household quantities may be used. Appliances with high nominal consumption (electric heaters, air conditioners, professional audio and lighting equipment) must not be connected. The charging of e-cars or e-scooters is expressly forbidden.

9. The liability of Hockenheim-Ring GmbH in the power supply extends exclusively to the safe operation of the power generators and the connected distribution cabinets. No liability is accepted in the event of voltage fluctuations or power failure and any resulting damage of any kind. Any liability on the part of Hockenheim-Ring GmbH ends at the mains socket with the residual current circuit breaker in the distribution cabinet. From this point onwards, campsite users/visitors shall be liable themselves for any damage to themselves or others caused by the laying of inappropriate distribution cables, the inappropriate use of the power supply and/or the connection or operation of inappropriate cables and/or appliances.
10. All waste must be disposed of in the bins provided. Paths, grounds and all facilities are to be treated with care and the sanitary facilities provided are to be used for their intended purpose. Urinating outside the designated toilets is forbidden.
11. Use of the campsite is at your own risk. Security surveillance is not provided. The lessor is not liable for damage of any kind (e.g. accidents, injuries, lost or damaged property) that occurs during the use of the site. This exclusion does not apply if the damage was caused by the lessor intentionally or through gross negligence.
12. Night rest must be observed between 10pm and 6am and between midnight and 6am on Friday and Saturday. The night rest must be observed in accordance with the legal provisions.
13. The instructions of the order and control personnel must be followed.
14. If you disregard the provisions of these campsite regulations as well as the house rules and the general terms and conditions of the Hockenheim-Ring GmbH, you may be expelled from the campsite or even prosecuted.
15. In addition to these campsite regulations, the house rules and the GTC of the Hockenheim-Ring GmbH apply. Should individual points of these campsite rules be completely or become partially invalid or unenforceable, the validity of the remaining points shall not be affected.
